Before me, the undersigned Assistant District Attorney of Harris County, Texas this day appeared the undersigned affiant, who under oath says that he has good reason to believe and does believe that in Harris County, Texas, MARIANN BACHARACH, hereafter styled the Defendant, heretofore on or about JUNE 7, 2013, did then and there unlawfully with intent to HARASS, ANNOY, ALARM AND TORMENT another, and in a manner reasonably likely to alarm ROGELIO GARCIA, the person who lives at [REDACTED] and hereafter called the Complainant, threaten to INFLICT BODILY INJURY ON THE COMPLAINANT; namely; DEFENDANT THREATENED TO KILL THE COMPLAINANT.

PROBABLE CAUSE

Affiant, Marco Leal, is a certified Texas Peace Officer employed with Harris County Constable's Office Precinct Six. Affiant has reason to believe and does believe that Mariann Bacharach, an adult female with date of birth of [REDACTED] who resides at [REDACTED] Milam #2, Houston, Harris County, Texas 77006, hereafter the defendant, committed offense of Harassment on about June 7, 2013, August 16, 2013 and August 31, 2013 at 6410 Pinehurst and 1317 Telephone Rd. in the [REDACTED] Houston, Harris County, Texas 77023. Affiant bases his belief on the following. Affiant spoke to Complainant, Rogelio Garcia, who affiant believes to be a credible and reliable person. The complainant stated he knows the defendant, Mariann Bacharach, by name and is right as his ex-girlfriend. The complainant stated he terminated the dating relationship in June 2013. Complainant stated the defendant called his cell phone repeatedly between Thursday, August 16, 2013 and August 19, 2013, by means of sending messages via text in a manner being, annoying, alarming, embarrassing and offending the complainant. Defendant made statements with the words "Fucking scumbag". "Kill you first!". "Your asspic". "Spies and niggers". "Please die please" and "What a fucking piece of shit". Defendant sent the complainant fifty-nine text messages. On June 7, 2013, Defendant arrived at Complainant's place of residence located 6410 Pinehurst Street, Houston, Harris County, Texas 77023. Defendant while at complainant's residence began to throw thirty-six to forty unwrapped condoms around the property and was careless whether or not the complainant would be offended. On August 31, 2013 Defendant again arrived at Complainant's place of residence and began to place on the property offensive fliers stating the words, "Roger Garcia gets women pregnant because he loves the drama of abortions! Roger Garcia disabled a woman to make her his sex slave". Defendant then traveled to complainant's place of business located at 1317 Telephone Rd, Houston, Harris County, Texas 77023 and began to also place on the property offensive fliers stating the words, "Roger Garcia gets women pregnant because he loves the drama of abortions! Roger Garcia disabled a woman to make her his sex slave". Nine offensive fliers were found on both properties.
